

## IDENTIFYING AND REPORTING CHILD ABUSE AND NEGLECT TRAINING

F.S. CHAPTER 39, SECTION 201 REQUIRES MANDATORY REPORTING OF KNOWN OR SUSPECTED CHILD ABUSE, ABANDONMENT, OR NEGLECT. F.S. 415 REQUIRES MANDATORY REPORTING OF KNOWN OR SUSPECTED ABUSE, NEGLECT, OR EXPLOITATION OF ADULT DISABLED STUDENTS.

Completion certificates should be maintained by a designated staff member in your school/location. Each school/location will be provided with a form to record staff completions and will provide a copy to Student Welfare & Attendance.
